We provide technical assistance to various Spanish Ministries, such as the Ministry of Economy and Finance, the Ministry of the Environment and Rural and Marine Affairs, as well as autonomous bodies such as the Carlos III Health Institute and the National Institute of Agricultural and Food Research and Technology (INIA).





Our clients also include a large number of Town Councils, Provincial Councils and Public Law Companies, as well as numerous companies benefiting from public subsidies. Since 2009, ARCA has been providing technical assistance to the Carlos III Health Institute for the management and subsequent verification of more than 300 annual grants subsidised by the ERDF in the different operational programmes in which it participates. It also provides technical assistance in the management and control of the EDUSI for the Logroño City Council. We would also like to highlight the technical assistance provided to intermediate bodies of the European Social Fund such as the Fundación Once, the Fundación Secretariado Gitano or FSC Inserta.
